The Circle K Regulators, New York's largest Single Action Shooting Society (SASS) affiliated Cowboy Action Shooting (CAS) club, wishes to offer your company the opportunity to become a sponsor and/or vendor at **HELUVA RUKUS**, the SASS New York State CAS Championship and the 2nd largest SASS event in the Northeast. A full-page ad for your company will be included in the HR '10 Shooter's Handbook and a smaller ad in our monthly club newsletter for the calendar year. Any banner supplied will be prominently displayed throughout the three-day event.

Stage/Side Event Sponsors will receive exclusive corporate promotion associated with one main shooting stage or one side event. A half-page ad for will be included in the HR '10 Shooter's Handbook and a smaller ad in our monthly club newsletter for the calendar year. In addition, information and/or a web or e-mail link to your company will be included on our web site (www.circlekregulators.com). Vendor space at Heluva Rukus is being offered for the cost of \$100, payable in cash, gift certificate(s), or merchandise. As noted above, any non-cash donations must be cowboy/western or shooting-related. Vendor space is limited; electricity even moreso, so reserve your space early. Priority for electrical hookups will be given to those vendors requiring it to conduct their business. In addition to the vendor space, we will list your company in the HR ‘10 Shooter’s Handbook and put a small ad in our monthly club newsletter for the year. Information and/or a web or e-mail link to your company will be included on our web site as well.

All funds and merchandise collected from you will be utilized solely for the purpose of providing prizes for the competitors. These prizes will be awarded through raffles, drawings, and other non-competitive events providing everyone an opportunity to take home a valuable and memorable gift from the shoot.
