# NOTES FROM THE TRAIL BOSS

July 15th, Cowboy Action Shooting at the Circle K. The weather was another factor. The threat of rain dampened some of shooters regular from coming. Little did they know we only had a few sprinkles in the morning and a small shower in the afternoon. It was enough to get wet and then make it humid afterwards. But, as always, all who were there had a great time. The humidity did manage to sneak up on a few people. For the first time, we had a shooter succumb to the heat and go down. But as always, the cowboys came to his aid with water and Gatorade and got him back on his feet.

We did call EMS to come and check on him. They cleared the shooter, but he went home right after the EMS left. Thanks for the fine work to all who aided in that emergency.

There were 58 shooters that got to shoot this day. All the stages were taken directly from End of Trail 2007. Rowdy Bill kept them as written and only changed a few props. We want shooters to see how scenarios are written and put together elsewhere. I know that on this day there were not too many clean shoots. Shooters who have never gotten a procedural got one. Rowdy hopes to pull 5 more stages from the End of Trail for our August shoot.

The Greenfield Lions Club was on hand to feed us once again. They did a great job serving hot hamburgers, dogs, sausage sandwiches, and beans. The food always tastes great since I don't have to cook (not that I won't if I have to). They did ask the shooters how many would be interested in having a chicken dinner next month. I know don't the outcome because they had packed up before I finished shooting. I will be in touch before the August shoot to find out their intentions and put out an email.

Muleskinner was one of the original founders of Circle K and one of the most devoted Cowboy Action Shooters around. It was a pleasure to help erect this in his honor. There were many people who helped make this building come

together in a short time. You all did a great job, and 'Thank You'. I know Muleskinner thanks you, too.

Another first for this shoot was our new pass from the permanent town stage straight out to the middle fields. This was welcomed since the heat and humidity got real heavy. This pass saved everyone the long walk around the chicken shack and bathrooms. Even though it wasn't completely finished, it was much easier than that long walk.

There is still more work being done at the club for HR 2007, including more earthwork as well as more tree removal. There are more props to build. We are trying to see if we can get one more permanent stage set. This is to be a mineshaft. But we know that time is important, and this may have to wait until next year. We are still looking for help for HR 2007.

Circle K members who plan to go to the Remington Demo Shoot on Saturday, August 12<sup>th</sup>, need to contact me so we can coordinate time and what we have to do at the shoot. Also some Circle K members are planning to go to the Tioga Sportsman Club on Saturday, August 4<sup>th</sup>, for some Cowboy Action Shooting. Tioga is a fairly new cowboy club located just east of Binghamton, N.Y. We do have to let these folks know how many are coming because they have a chicken dinner for lunch with your paid admission to the shoot. We hope to coordinate a time and place to leave from so we can carpool as much as possible due to gas prices.

#### **JULY MONTHLY SHOOT**

We finally got an opportunity to use our awesome new building on Stage 10, and it worked out great. We also got to use the cut-through between Stages 7 and 8 - a nice time (& leg) saver. The Lions Club once again did a great job keeping

the cowfolk fed. The only downside to the day was that one of our cowboys got dehydrated, and medical assistance had to be called. PLEASE, folks, even if you think it's not that hot or that you're not sweating that much, remember to keep hydrated. Drink, drink, drink! The CKR will try to do better with putting water out on the stages, too.
